CODE OF CONDUCT

Through your Membership of Westport Golf Club you will be bound to abide by the Westport Golf Club's Code of Conduct. You will be required to observe the highest standard of behaviour. As an ambassador for your Club, and for the game of golf in general, it is important that you understand fully what is required of you throughout the entire time you are a member of Westport Golf Club. The Club undertakes to provide for your wellbeing while you are in the care of the Volunteers and Coaches engaged by the Club.

In accepting Membership you are required to agree to accept and undertake the following requirements:

1. Observe any instructions, restrictions requested by the Volunteers/Coaches without dissent.
2. Demonstrate the highest standard of behaviour and conduct at all times, both on and off the course, to Club Volunteers, club members and staff, other players, and members of the public.
3. Behave in a sportsmanlike manner as befits the conduct associated with being a member of Westport Golf Club and display a professional attitude to personal organisation, training and dress.
4. To report all accidents, no matter how trivial, to the Junior Volunteers/Coaches.
5. To accept and abide by any travel arrangements made on your behalf by the Westport Golf Club when visiting other Courses/Clubs for golf activities.
6. Not to use bad language either on or off the golf course

I understand and agree that in the event of my being in breach of the above standards of conduct, I shall render myself liable to be withdrawn from the organized activities.

I agree to accept unequivocally the terms and conditions detailed above, together with all reasonable instructions and requests made of me by the Junior Volunteers/Coaches at all times.
